This understanding witnesses the following:

1. Where as a party of placement and industrial internship services among the students of B.H.B College, Sarupeta, (1<sup>st</sup> party) proposes for placement of eligible students under M/S J. B. Industry. The first party will provide eligible candidate for placement and Industrial internship. Where as the 2<sup>nd</sup> party send the 1<sup>st</sup> party the requisition list to be placed at their establishment and when they receive the recommendation letter from the 1<sup>st</sup> party. Where as the party has desired and agreed to provide required assistance, the details of which are mentioned below, in this regard to the 1<sup>st</sup> party for smooth conduct of the placement service and Industrial internship program as per the following terms and conditions.

1. It is agreed that the 2<sup>nd</sup> party will provide resource person required materials for Industrial internship program to the 1<sup>st</sup> party.

2. The 1<sup>st</sup> party faculty with the help of the 2<sup>nd</sup> party will motivate students to take up the Industrial Internship program.

3. This arrangement will be responsibility sharing basis between the 1<sup>st</sup> party and the 2<sup>nd</sup> party as follows. The roles and responsibilities of the 1<sup>st</sup> party and the 2<sup>nd</sup> party are spelt out below:

4. Responsibilities of B.H.B. College Sarupeta (herein after references to as the 1<sup>st</sup> Party)

4.1.1; 1<sup>st</sup> party will provide the detailed list of students for industrial internship program as and when needed by the 2<sup>nd</sup> party.

4.1.2; 1<sup>st</sup> party will provide the recommendation for placement of students soon after the receipt of the requirement for the same.

4.1.3; The 1<sup>st</sup> party will recommend the names of student for industrial internship Programme along with the name of job placement as per the norms and procedure laid down by the 1<sup>st</sup> party.

**Responsibilities of J.B. Industry, Hathinapur, Bangti (herein after referred to as the 2<sup>nd</sup> Party)**

4.2.1; The 2<sup>nd</sup> party will provide instructors for industrial internship programme as per requirement to help the instructors belonging to the 1<sup>st</sup> party.

4.2.2; The 2<sup>nd</sup> party will provide materials when necessary for taking industrial intrensrhip programme.

4.2.3.; The 2<sup>nd</sup> party will help the 1<sup>st</sup> party in motivating the students for Industrial Internship programme.

**5. Arbitration;**

Any dispute arising out of or in connection with the contract, or in respect of any defined legal relationships associated thereof or derived there from would be initially settled by the principal B.H.B. College, Sarupeta failing which the parties agree to submit that dispute to arbitration under the ICADR Arbitration eules,1996 . The authority to appoint the arbitrator shall be the international centre for Alternative dispute resolution. The international centre for alternative dispute resolution will provide administrative services in accordance with the ICADR Arbitration rules, 1996 and the expanses on arbitration shall be equally born by both the parties.

**6. Jurisdiction;**

The court of the Sessions Judge, Bajali will be the Jurisdiction.

**7. Validity, Renewal, Termination of MOU**

7.1; this MOU is valid till 2025.

7.2; This MOU can be renewed further under similar terms subject to mutual agreement.

7.3; The MOU can not be terminated before the validity period by any party.

**8. Notice;**

Any notice, request, demand, approval, consent, or other communications provided or permitted here under shall be in writing and given by personal delivery, by post or by e-mail.
