ARTICLE 6

AMENDMENT

- A. This MoU may be amended or revised at any time by mutual written consent of both the Parties.
- B. Such amendment or revision shall come into force on the date as may be determined by both the parties.

ARTICLE 7

ENTRY INTO FORCE, DURATION AND TERMINATION

- A. This MoU shall enter into force on the date of signing.


