The 1st PARTY will admit and register the candidates as per the norms and procedure laid down by the 1st PARTY.

The maintenance of training quality, training delivery and conduct of sports event is the responsibility of the 1st PARTY, and the 2nd PARTY will provide all possible support in this regard, such as providing resource persons, required equipment etc.

The 2nd PARTY's responsibilities

The 2nd PARTY will provide instructors for taking practical classes as per requirement to help the instructors/resource persons belonging to the 1st PARTY.

The 2nd PARTY will provide equipment when necessary for training activities

The 2nd PARTY will help the 1st PARTY in conducting training as per requirements.
