This understanding witnesses the following:

1. Where as a party of placement and industrial internship services among the students of B.H.B College, Sarupeta, (1st party) proposes for placement of eligible students under Bajali Milk Parlour. The first party will provide eligible candidate for placement and Industrial internship. Where as the 2nd party send the 1st party the requition list to be placed at their establishment and when they receive the recommendation letter from the 1st party. The 2nd party do the needful for their placement in different categories.

Also, the 2nd party will place the required member of students for Industrial internship, the 1st party will recommend the same to the 2nd party as when needed for the internship under different categories. Where as the party has desired and agreed to provide required assistance, the details of which are mentioned below, in this regard to the 1st party for smooth conduct of the placement service and Industrial internship program as per the following terms and conditions.

 It is agreed that the 2nd party will provide resource person required materials for Industrial internship program to the 1st party.

3. This arrangement will be responsibility sharing basis between the 1st party and the 2nd party as follows. The roles and responsibilities of the 1st party and the 2nd party are spelt out below:

- Responsibilities of B.H.B. College Sarupeta (herein after references to as the 1st Party)
- 4.1.1; 1st party will provide the detailed list of students for industrial internship program as and when needed by the 2nd party.
- 4.1.2; 1st party will provide the recommendation for placement of students soon after the receipt of the requirement for the same.
- 4.1.3; The 1st party will recommend the names of student for industrial internship Programme along with the name of job placement as per the norms and procedure laid down by the 1st party.

Responsibilities of Bajali Milk Parlour, Vill- Ratanpur, PO- Barbang, Dist- Barpeta (herein after referred to as the 2nd Party)

- 4.2.1; The 2nd party will provide instructors for industrial internship programme as per requirement to help the instructors belonging to the 1st party.
- 4.2.2; The 2nd party will provide materials when necessary for taking industrial intrenrship programme.
- 4.2.3.; The 2nd party will help the 1st party in motivating the students for Industrial internship programme.
- 4.2.4.; The 2nd Party will provide placement as per the requirement.

5. Arbitration;

Any dispute arising out of or in connection with the contract, or in respect of any defined legal relationship associated thereof or derived there from would be initially settled by the principal B.H.B. College, Sarupet failing which the parties agree to submit that dispute to arbitration under the ICADR Arbitration eules,1996 The authority to appoint the arbitrator shall be the international centre for Alternative dispute resolution. The international centre for alternative dispute resolution will provide administrative services in accordance wi the ICADR Arbitration rules, 1996 and the expanses on arbitration shall be equally born by both the parties.

6. Jurisdiction;

The court of the Sessions Judge, Bajali will be the Jurisdiction.

- 7.1; this MOU is valid till 2026.
- 7.2; This MOU can be renewed further under similar terms subject to mutual agreement.
- 7.3; The MOU can not be terminated before the validity period by any party.
